ASF specialises in the development of projects aimed at promoting and supporting access to justice, the upholding of human rights and the rule of law in post conflict and/or developing countries. ASF has permanent offices in Burundi, DR Congo, Uganda, Central African Republic, Chad and Tunisia.

Context

Active in Indonesia since 2017, ASF, in close collaboration with several local partners, seeks to empower Indonesian community-based service providers (LASPs) to offer quality holistic services to justice seekers. The problems citizens face are rarely only legal: if they want their actions to be efficient, the LASPs need to take justice seekers' social, economic and physical environment into account, and provide global answers to their needs. ASF's robust evidence-based approach will provide information on their perspectives, concerns and needs in order to improve the understanding of the legal needs of the service providers and their communities for the purposes of capacity-building and advocacy.
